

Appointment of Maurits Daniel Rudolf Lalisang as President Commissioner and Nurhadijono as Commissioner of PT Multi Bintang Indonesia Tbk.

Jakarta, October 25th 2019 – PT Multi Bintang Indonesia Tbk (MLBI) today at the Extraordinary General Meeting of Shareholders appointed Maurits Daniel Rudolf Lalisang as President Commissioner of the company to succeed the late President Commissioner Cosmas Batubara who headed the company for 21 years since 1998 until his passing away on August 8th, 2019. His previous senior posts include Corporate Relations Director, Foods Director, Home Care Director and Sales Director at PT Unilever Indonesia Tbk. He is currently also Partner at PT Saratoga Investama Sedaya Tbk, Independent Commissioner at PT Deltomed Laboratories and Independent Commissioner at PT ICI Paints Indonesia.

Nurhadijono holds a bachelor's degree in economics from the University of Rochester in Rochester, New York, and an MBA in International business and finance from Pace University, New York. Now, he is a President and CEO of Cardig International, the largest independent third-party aviation and logistics specialist in Indonesia. Currently, Cardig International comprises 10 subsidiaries whose activities include aviation services, logistics, catering and security services. He joined the Board of Directors of the company as the Vice President Director of JAS Airport Services in 1998 after serving as a commissioner since 1994. He is also President and CEO of Cardig Aero Services, and Vice Chairman of UPS Cardig International, a joint venture between Cardig International and UPS. Nurhadijono is Head of Permanent Committee for The Americas and International Economic Institutions of the Indonesia Chamber of Commerce and Industry. He is also the current Regional Forum Officer for YPO Southeast Asia Region.
